IN 2022, WE HELD A NATIONAL CONFERENCE THAT CONVENED ALMOST 700 GRANTMAKERS BOTH IN PERSON AND VIRTUALLY DUE TO THE ONGOING COVID PANDEMIC. ABOUT 600 PARTICIPANTS GATHERED IN CHICAGO TO CONNECT WITH EACH OTHER AND HEAR FROM DYNAMIC SPEAKERS ON TOPICS RELATED TO SHIFTING PHILANTHROPIC CULTURE. WE ALSO HOSTED APPROXIMATELY 100 MEMBERS OF OUR COMMUNITY IN A VIRTUAL CONFERENCE THAT TOOK PLACE ONLINE IN THE WEEKS FOLLOWING THE IN-PERSON GATHERING. IN BOTH CONFERENCE SETTINGS, PARTICIPANTS EXCHANGED IDEAS AND DEEPENED THEIR SKILLSET RELATED TO ADVANCING RACIAL-EQUITY CENTERED CHANGE IN THEIR ORGANIZATIONS AND THE ADOPTION AND IMPLEMENTATION OF PHILANTHROPIC PRACTICES THAT LEAD TO THRIVING COMMUNITIES.
